STIPULATION

The parties hereby stipulate and agree as follows:

1. On October 3, 2017, the Court entered an Order Granting Motion for Preliminary Approval of Class Settlement, Certifying Settlement Class, Directing Issuance of Settlement Notice, and Scheduling Hearing on Final Approval ("Preliminary Approval Order").

2. In the Preliminary Approval Order, the Court set the remaining schedule for the case, including the Fairness Hearing, with some dates calculated forward from the date of entry of the Preliminary Approval Order, and other dates calculated backward from the date of the Fairness Hearing. *Id.* at 6-7.

1 15. After conferring with the parties, the Court scheduled the Fairness Hearing for
 2 Tuesday, March 20, 2018, at 4 pm. Based on that Fairness Hearing date and the date of entry of
 3 the Preliminary Approval Order on October 3, 2017, the parties hereby stipulate and request that
 4 the remaining Case Schedule be adopted and entered by the Court, as follows:

5	1	Northwest Hospital to transmit list of patients and addresses for notice purposes to Claims Administrator (30 days from entry of Preliminary Approval Order)	November 2, 2017
6	2	Claims Administrator to cause notice to be sent and establish case Website (44 days from entry of Preliminary Approval Order)	November 16, 2017
7	3	Claims Administrator to publish in Seattle Times (58 days from entry of Preliminary Approval Order)	November 30, 2017
8	4	Deadline for members of the Class to file comments or objections to the Settlement Agreement with the Court (104 days from entry of Preliminary Approval Order)	January 15, 2018
9	5	Deadline for members of the Class to submit Opt-Out Statement to the Claims Administrator (104 days from entry of Preliminary Approval Order)	January 15, 2018
10	6	Deadline for Class Counsel to file Motion for Final Approval of the Settlement Agreement (21 days before Fairness Hearing)	February 27, 2018
11	7	Deadline for Class Counsel to file Motion for Attorney Fees, Litigation Costs and Service Awards (21 days before Fairness Hearing)	February 27, 2018
12	8	Deadline for Northwest Hospital to file Declaration of Notice Procedures and Opt-Outs (14 days before Fairness Hearing)	March 6, 2018
13	9	Deadline for Class Counsel and/or Northwest Hospital to respond to any timely filed objections (14 days before Fairness Hearing)	March 6, 2018
14	10	Fairness Hearing (at least 164 days from entry of Preliminary Approval Order)	March 20, 2018, 4 pm
